

ABBREVIATED OFFICIAL RULES

Must be a legal resident of Japan, 18 years of age or older. Starts **Friday, 12 September 2025** at 12:00 noon Japan Standard Time (“**JST**”), and ends on **Tuesday, 30 September 2025** at 23:59:59 pm JST. FULL OFFICIAL RULES

HOW TO ENTER: Entrants must have access to the Internet and must have a valid account with Instagram to enter this Campaign. To participate, entrants must do all of the following during the Campaign Period: (a) visit the Sponsor’s official Instagram page (@hiltonkyoto) (“**Sponsor’s Page**”) during the Campaign Period and be a follower of the Sponsor’s Page; following Sponsor’s Page is free; (b) ‘like’ the Campaign post and leave a comment with their answer to the question “If one wish can be granted, what would you like to do in Kyoto”.
